Welcome to the 2016–17 FWSA Council's Man & Woman of the Year Competition.

The Application

- The award covers the past **FIVE** years of service only— (2012–2017).
- Responses are limited to the boxes provided.
- The same activity should not be listed under multiple categories. For example, if you were your club's rep for your Council, you can list it under club or council, but not both.
- The application must be filled out electronically using the FREE Acrobat Reader or a similar app.
- ALL applications must be **e-mailed** to me by the deadline March 26, 2017. If the deadline creates a hardship, please contact me so we can work something out.

Lessons Learned

What we found out last year is that the PDF applications are **NOT** compatible with Microsoft VISTA Operating System. If you are still using old operating systems that are no longer supported by Adobe, you will need to find someone in your club or council to help you fill out the application.

You will need the very **LATEST** copy of Adobe Reader. It's **FREE** and can be downloaded at <https://get.adobe.com/reader/>. Also Apple's Preview seems to work for Mac 10.6.8 OS X and above.

The Judges

- Judges names with their contact information needs to be provided by the March 26, 2017 deadline.
- Judges must be able to process and judge electronic media (PDF files).
- Each judge will be given an Excel Spread Sheet for assigning scores.
