
You all have provided Michael the proof that this is the correct path and he is secure in it. Be it known each of you is beloved by him and he holds each of you close to his heart.

accommodations. All of this information, and more can be found on the Members Benefits Page of the Far West website.





# China was an Exotic Trip

This past year has been a great traveling experience for those members of the Far West Ski Association that chose to join us on the China adventure and later on the Zermatt Switzerland and Egypt trip.

The first group of 34 flew out of San Francisco in mid-September for a two-week exotic journey to China and the Yangtze River. We arrived early evening in Beijing, the vibrant capital of China. The next day we visited Tiananmen Square, the world's largest and most famous square. This was followed by a visit to the Forbidden City and a glimpse of the opulent lifestyles of the Chinese Emperors and their concubines. After lunch we visited the picturesque Summer Palace on Kunming Lake.

The next day we traveled by motor coach to explore the Great Wall, one of the Seven Wonders of the World, followed by a visit to the Ming Tombs and the Sacred Way.

The next day we flew to Wuhan to see the Hubei Provincial Museum and then on to Yichang to board our cruise ship. During the next five days on the Yangtze River we visited the construction site of the Three Gorges Dam. We went through the locks at the dam and sailed through the spectacular Xiling Gorge, the longest of the Three Gorges. Took a small riverboat up the Shennongxi Stream tributary for a close-up view of the local people and wildlife. We cruised through the Wu Gorge, with its deep zigzagging valley and lush forested mountains, and the Qutang Gorge, last of the three.

After departing the cruise ship in Chongqing and visiting the Panda Bears, we flew to Xian to see the world famous 6,000 Terra Cotta warriors, horses and chariots buried with the first Chinese Emperor, Qin Shihuang. From Xian we traveled to Suzhou to visit the Garden of the Fishing Net Master, the Silk Spinning Factory and a boat ride on the Grand Canal.

The last couple of days we spent in Shanghai, one of the most modern cities of the world. We visited the Shanghai Museum, the Bund, Yu Yuan Garden Bazaar and the place most tourists do not get to visit, the Xiang Yang Clothing Market or "knock-off market" which had a Tommy Bahama shirts for only \$10

US. Along the way we saw an Acrobatic show and a traditional Tang Dynasty Music and Dance Show.

As soon as the two-week group flew out of Shanghai for home, Kathy and I flew to Beijing to meet the next group of 50

From Guilin we traveled by motor coach through lush countryside to a small village to embark on a three-hour cruise up the scenic Lijiang River to Yangshou. After dinner in Yangshou, the group went by bus to a natural amphitheater on the shores of a lake surrounded by mountains. There, we watched in awe, one of the most spectacular musical productions ever performed; a

Both groups had an amazing time and will long remember their adventure in China.



Telluride's groomed trails, bowls, glades and chutes provided great skiing for every ability level. Thanks to Gloria, Marilyn, Ken, Bob, Nancy, Patrick, Kurt, and our trip leaders for their work to make this ski week such a success.

### 2006 Panama Canal Cruise

You'd better hurry if you want to sign-up for the FWSA Panama Canal Cruise! You can use your credit card and sign-up on line at [www.fwsacruises.com](http://www.fwsacruises.com). We set sail from San Diego on Sunday, October 29, cruise through the Panama Canal and arrive in San Juan, Puerto Rico on Saturday, November 11. Our ports of call

include Cabo San Lucas, Acapulco and Huatulco, Mexico; Puntarenas, Costa Rica; and Oranjestad, Aruba.

This thirteen night cruise is aboard Royal Caribbean's Serenade of the Seas. The ship has a solarium



with an indoor/outdoor swimming pool with six whirlpools and a sliding roof. The Ship Shape Day Spa provides full service treatments, sauna and steam room, a fully equipped fitness center and aerobics classes. The Royale Casino has blackjack, roulette, craps, Caribbean stud poker and slot machines. In addition to the dining room, a buffet for casual dining and several cafes, bars, grills and lounges, the Serenade of the Seas offers 24 hour room service. There is always plenty to do aboard this ship!

Current prices range from \$1289 for an inside cabin to \$1689 for an ocean view cabin to \$2119

Steamboat is the location of our 2007 ski week. Located in the Colorado Rockies, Steamboat is one of North America's largest ski mountains. With 143 trails, 3600 vertical feet, and nearly 3,000 skiable acres, Steamboat provides a variety of terrain for every level of skier. The trail classification is 13% beginner, 56% more difficult and 31% advanced/expert. There are definitely runs for every skier.

Steamboat is a complete mountain range with Mt. Werner, Sunshine Peak, Storm Peak, Thunderhead Peak, Christie Peak and Pioneer Ridge. Steamboat's six peaks are filled with groomed cruisers, bumps, steps, open meadows, and legendary tree skiing. The term "champagne powder snow" was coined in Steamboat.

The last time the FWSA ski week was in Steamboat was 1997, when we had 640 participants. Several councils are already taking sign-ups, so contact your council trip leader. 



I was able to ski with the top mono-skiers, which included 12 time Paralympian gold medalist, Sara Will and US ski team member Bill Bowness and many other exceptional adaptive skiers.

There were about 10 monoskiers in addition to many other adaptive disciplines participating in the camp. I was able to gain many ski tips to improve my skiing ability. I learned sooo much and had such a great time skiing with all these people and getting to know them. AND by the end of the week, I finally accomplished something I never thought I would, I loaded, rode, and unloaded the ski lift all by myself - yeah!!! AND, I completed the NASTAR course 3 times without a single "Wild World of Sports" moment (at least the agony of defeat part!).

Between the LA Council, the FWSA and the mono ski camp, we were kept very busy and enjoyed lots of great food! We stayed at the Victorian Inn which was only a block or so away from the Gondola. The weather was perfect. There was fresh snow from the week prior to our arrival, so the snow was perfect and the skies were blue the entire week.

The resort of Telluride is AWE-SOME! The town is very charming with its Victorian homes, the Gondola and the Mountain Village. The people were friendly and the ski lift lines were virtually nonexistent.

Thanks to the generosity and friendliness of L.A. Council and the wonderful ski club members, both Gina and I will have memories to cherish for a lifetime. Thank you, thank you, thank you!

I highly recommend a visit to Telluride!!!!

# ***Lapses in Safety Consciousness***

Did you ever notice that accidents don't happen when you are being careful?

They seem to occur when you let your guard down and are not expecting them.

As an example, I had a little disagreement with my right knee, not when I was blasting down a double black diamond tree run, but in a lift line when I was not paying too attention. My good buddy crashed and tore his rotator cuff just as he was slowing down to go into the lodge.

Statistics show that many ski fatalities occur on intermediate slopes. How does this happen? I consider these events to be lapses in Safety Consciousness.

We all have a 'set-point' as to what we consider part of our normal attentiveness at work, at home, driving, or participating in sports like skiing and boarding.

Many times we are distracted by one thing or another and we drift off from our safety consciousness. This is when we are most vulnerable. Issues which may divert us are commonplace: talking on the cell phone, listening to an MP3 player while skiing, looking

at something on the slopes, or even chatting while walking on slippery areas.

Some high risk areas to especially watch out for:

- Confluences of runs where other skiers and boarders go to a common trail
- Intermediate runs where you are blasting swiftly
- Race courses
- Icy parking lots, stairs, or walkways with ski boots on.
- Flat lighting or poor visibility on the slopes.
- Crowded ski runs with many beginners

Always watch all sides, be aware of conditions and your surroundings.

Consider where your own level is, check it regularly and remember, when you drift away from this, it is when you may get hurt.

Safety is no accident. Safety is Having Fun Consciously!

Travel plans are set for the BAC in 2007. There is a BAC trip plan to visit Panorama and then there is the FWSA trip to Steam-


boat Springs. I understand that we have asked for 160 pillows in Steamboat! We are continuing with plans to add a trip for the Singles League portion of the BAC.
